<p>Exercise Objective: Demonstrate the ability of the Liberty County EOC to identify, prioritize, and coordinate required resources for addressing disaster survivor needs following a large-scale natural disaster in accordance with established plans and procedures.</p>
<p>Core Capability: Mass Care Services</p> <p>Provide life-sustaining and human services to the affected population, to include hydration, feeding, sheltering, temporary housing, evacuee support, reunification, and distribution of emergency supplies.</p>
<p>Organizational Capability Target 1: Establish staff and equip emergency shelters and other temporary housing options for an unknown number of affected residents within 24-72 hours. Provide life sustaining services with a focus on hydration, feeding and sheltering as well as support for reunification of families.</p> <p>Critical Tasks:</p> <ol style="list-style-type: none"> a. Coordinate the activities of Support Entities within ESF #6 to fulfill operational objectives. b. Direct the activities of the ESF #6 in conjunction with assistance from ESFs at the local, State, or Federal levels as applicable. c. Share ESF #6 activity information with appropriate EOC personnel. d. Prioritize ESF #6 operational strategies in alignment with the EOC and on scene objectives. e. Maintain contact with emergency shelters to coordinate ongoing operations and identify potential resource needs. f. Oversee reunification operations in coordination with Supporting Agencies. g. Ensure all appropriate and proper protocols are followed in all established emergency shelters. h. Work with community groups and existing partner agencies to identify unmet mass care needs within Liberty County. i. Provide emergency welfare assistance to eligible disaster victims within approved local, state and federal guidelines. j. Work with Child Care partners to provide emergency childcare services in Emergency Shelters. k. Work with Adult Protective Services to connect elderly displaced individuals with social services and other resources that can support them both within the Emergency Shelter and in the transition back to their place of residence.

- l. Coordinate with ESF #14 – Long-Term Recovery to identify long-term housing needs and potential resources.
- m. Coordinate with ESF #15 – Emergency Public Information for the inclusion of appropriate information for public dissemination.
- n. Coordinate with ESF #8 – Public Health & Healthcare Providers partners to address access and functional needs as it relates to Mass Care operations.
- o. Coordinate with ESF #8 partners to ensure medical and mental/behavioral health services are accessible at or through shelter locations.
- p. Coordinate with ESF #8 partners to assure food and water safety inspections of any established feeding operations sites in their jurisdiction.
- q. Work with emergency shelter operators to ensure health screenings of displaced individuals and households upon arrival and registration at emergency shelters.
- r. Work with emergency shelter operators to ensure medication needs at emergency shelters are met.
